<b>Change of Control:</b>	Upon the occurrence of a change of control (as defined), the Issuer must offer to repurchase the Notes at 101% of the aggregate principal amount of the Notes, plus accrued and unpaid interest to the date of repurchase.
<b>Denominations:</b>	\$25.00 minimum denominations and \$25.00 integral multiples in excess thereof.
<b>Exchange:</b>	The Issuer intends to apply to list the Notes on the NASDAQ Global Market. If the application is approved, the Issuer expects trading in the Notes on the NASDAQ Global Market to begin within 30 days after the settlement date.
