(f/k/a Cowen Group, Inc.), Cowen Group, Inc. (f/k/a LexingtonPark Parent Corp.), Lexington Merger Corp., Ramius LLC (f/k/a Park Exchange LLC) and RCG (the "Transaction Agreement"). The Reporting Person may be deemed a director by deputization of the Issuer by virtue of its right to appoint six of the directors of the board of directors of the Issuer pursuant to the Transaction Agreement as of the closing of the Transactions.
